Feedback from students is above 60% percent, so no action taken here

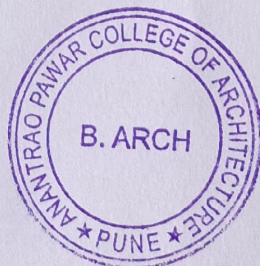
### Feedback from Teachers:
